

Model Release

PLAIN SUMMARY

This document lets the Photographer publish and use only the images the Model approves in writing.

The Model can set written privacy limits, including face-anonymous publication. This release does not transfer copyright or give the Model ownership of the image files.

PARTIES

This release is between Ignat Kudriavtsev, later referred to as the Photographer, and the model or collaborator named below, later referred to as the Model. Together they are referred to as the Parties.

PARTICIPATION IN THE SHOOT

The collaborator agrees to participate in the agreed TFP collaboration with the Photographer.

Participation applies only to the shoot and image scope discussed by the Parties. The Model may pause, adjust, or stop participation during the session.

The Model confirms that they are 18 years of age or older.

IMAGE REVIEW

Only selected edited images are considered for publication. The Model may review a proposed publication selection before approval.

PUBLICATION APPROVAL

The Model may approve specific images for publication. Approval should identify the approved images and any specific limits the Parties want to apply.

Approved image IDs or filenames:

Approval may be given by physical signature, electronic signature, email, message, gallery selection, contact sheet, filenames, image IDs, or another written method that reasonably identifies the approved images and the sender.

If filenames, export names, or file formats later change, approval still applies to the same visual images. Silence or lack of response is not approval.

Unless a specific limit or expiry date is written above, approval for the approved images has no expiry date and applies worldwide.

Images not approved for publication remain private unless later approved in writing.

For couple or group sessions, each identifiable participant should approve publication separately.

RELEASE AND PERMISSION

For images approved under this release, the Model authorizes the Photographer to edit, change, crop, retouch, copy, reproduce, display, publish, distribute, license for publication, and otherwise use those images for lawful professional, artistic, portfolio, promotional, editorial, exhibition, competition, print, press, web, social media, magazine, journal, book, article, presentation, and similar publication uses.

This permission includes use by the Photographer and publication or display by magazines, journals, books, galleries, exhibitions, portfolio reviewers, websites, social media platforms, printers, editors, agents, and similar professional or artistic publication partners involved in the approved use of the images.

The Photographer may decide how the approved images are edited, sequenced, cropped, displayed, captioned, and presented, provided the use remains within this release and any written privacy limits.

The Photographer owns the copyright to the photographs under applicable copyright law. This release does not transfer copyright to the Model and does not give the Model ownership of the image files.

COMPENSATION

The Model understands that this is a TFP collaboration unless another written agreement says otherwise. The Model is not entitled to payment, royalties, license fees, or other compensation for approved uses covered by this release.

PRIVACY AND FACE ANONYMITY

The Model may request privacy limits, including face-anonymous publication, cropping, silhouette, shadow, fabric coverage, no public name credit, or exclusion of identifying details.

Approved privacy limits:

Privacy limits may refer to the face, name, tattoos, distinctive marks, location, metadata, wardrobe, or other identifying details. Images approved as face-anonymous should not be published in a way that, to the Photographer's reasonable knowledge, clearly identifies the Model.

USAGE LIMITS

Approved images may not be used for adult entertainment advertising, escort-style promotion, paid content platforms, defamatory use, misleading endorsement, political endorsement, or unrelated commercial product advertising without separate written agreement.

Approved images may be used only for lawful purposes and may not be presented in a way that falsely suggests the Model endorses an unrelated product, service, political cause, or organization.

RIGHTS AND CLAIMS

For approved uses within the written scope of this release, the Model releases the Photographer from claims connected to editing, change, cropping, retouching, copying, publication, display, distribution, licensing for publication, or promotional use of the approved images.

This release covers only the approved uses listed above. It does not apply to uses outside the approved scope, unlawful use, false endorsement, or uses that breach the privacy limits written in this document.

WITHDRAWAL OR CHANGES

If the Model later has concerns about a published approved image, they should contact the Photographer. Removal or changes will be considered in good faith, but a concern or removal request does not automatically cancel this release or the approved scope.

This does not require the Photographer to recall printed materials, remove third-party publications, recover cached copies, undo prepared publications, stop uses already made within the approved scope, or stop future approved uses unless the Photographer agrees to that change in writing.

This does not affect any rights the Model may have under applicable data protection law. Those rights will be considered together with the Photographer's legitimate interests, legal rights, authorship interests, archive needs, freedom-of-expression interests, and already prepared, published, distributed, licensed, printed, cached, or third-party uses.

LEGAL TERMS

This release is governed by Finnish law unless the Parties agree otherwise in writing. This document replaces earlier discussions about the same subject. Together with any TFP agreement, client release, and written image-specific approval terms signed for this collaboration, it is the full agreement between the Parties on this subject. If one part cannot be enforced, the rest remains in effect as far as legally possible. Written approval, written permission, and signatures may be given by physical signature, electronic signature, email, message, gallery selection, or another written method that reasonably identifies the sender and the agreed terms.
